Rotator Sprinkler Nozzles (Residential/Commercial)	Water-efficient nozzles deliver streams of water that reduce evaporation loss.	Up to \$5/nozzle; replacement only. (Limit 20 nozzles household/200 Commercial)
Rain Sensors (Residential)	Detects rainfall and overrides irrigation system.	Up to 50% of the purchase price (maximum \$50). (Limit one per household)
Evapotranspiration Controller (Residential)	Regulates irrigation based on temperature, rainfall and humidity.	Up to 50% of the cost of the controller (maximum \$300). (Limit one per household)
Evapotranspiration Controller (HOA/Commercial)	Regulates irrigation based on temperature, rainfall and humidity.	Up to 50% of the cost of the controller (maximum \$300/each). Limit 5 controllers per HOA/Commercial customer.
Sod Replacement (Residential)	Replace sod with WaterWise Plants (Xeriscaping).	\$0.50/sq. ft. (500 sq. ft minimum. 4,000 sq. ft. maximum.) <u>The Metro District must first review & approve plan.</u> Customer must submit before and after photos and all landscape material receipts. Can be used in addition to NEW lawn replacement program!
Sod Replacement (HOA/Commercial)	Replace sod with WaterWise Plants (Xeriscaping).	\$1.00/sq. ft. (5,000 sq. ft minimum. 15,000 sq. ft. maximum) <u>The Metro District must first review & approve plan.</u> Customer must submit before and after photos and all landscape material receipts.
Water Efficient Showerhead (Residential)	Uses 1.5 gallons or less per minute versus 3 to 4 gallons.	\$10/showerhead. (Limit 4 per household; replacements only.)

* Rebate requests must be accompanied by the attached Rebate Request Form, a copy of the applicable sales receipt, and a picture of the installed item(s). CPNMD will credit rebates only to the applicable property owner's water bill. Rebates are available for property owners only; renters are ineligible. The rebate amount must not exceed the purchase price. Rebate funds are limited; available on a first-come, first-served basis; and only for the cost of approved devices itself. - All rebate requests must be accompanied by this request form, and by a copy of the applicable sales receipt and a picture of the installed item. Rebates will appear as an adjustment on your water bill.
- Rebates are available for property owners only. Renters of property in Castle Pines are not eligible.
- Participants in this Rebate Program understand "rebate funds" are limited for this program, and funds are on a first-come, first-served basis; and in no terms is the participant guaranteed a refund in this program.
- Participants understand this Rebate Program is for the cost of approved devices only. Installation costs are not covered by this Rebate Program.
- Metro District staff may schedule an appointment to inspect the new fixture(s) after installation.
- In no case will the rebate amount exceed the purchase price.
- Rebates for evapotranspiration controllers, sprinkler heads, rain sensors, toilets, and shower heads will apply to replacement items only. There is a one time rebate per household.
- Old toilets must not be sold for reuse.

- Rotator Sprinkler Nozzles**
Water-efficient nozzles deliver streams of water that reduce evaporation loss. Rebate: up to \$5 nozzle; replacement only. (Limit 20 nozzles per household or 200 nozzles per HOA or Commercial.)
- Rain Sensors**
Detects rainfall and overrides irrigation system. Rebate: Up to 50% of the purchase price (maximum \$50). Limit one per household.
- Evapotranspiration Controller (Residential)**
Regulates irrigation based on temperature, rainfall and humidity. Rebate: up to 50% of the cost of the controller (maximum \$300). Limit one per household.
- Evapotranspiration Controller (HOA/Commercial)**
Regulates irrigation based on temperature, rainfall and humidity. Rebate: up to 50% of the cost of the controller (maximum \$300/each). Limit 5 controllers per HOA/Commercial customer.
- Sod Replacement (Residential)**
Replace sod with water wise plants (Xeriscaping). Rebate: \$0.50/sq. ft. 500 sq. ft. minimum. 4,000 sq. ft. maximum. CPNMD must first review and approve the plan. Customer must submit before and after photos and all landscape material receipts.
- Lawn Replacement Additional benefit- Sod Replacement (Residential)** (after planting following Resource Central Sod Removal Program) Rebate: \$0.50/sq. ft. 200 sq. ft. minimum. 4,000 sq. ft. maximum. Customer must apply separately for CPNMD rebate, **MUST** Submit a photo of **Completed** Landscape project to Resource Central to be eligible. Drip irrigation, rotary nozzles, or similar must be used. Or irrigation system in area removed entirely.
- Sod Replacement (HOA/Commercial)**
Replace sod with water wise plants (Xeriscaping). Rebate: \$1.00/sq. ft. 5,000 sq. ft. minimum. 15,000 sq. ft. maximum. CPNMD must first review and approve the plan. Customer must submit before and after photos and all landscape material receipts.
- Water Efficient Showerhead**
Uses 1.5 gallons per minute or less versus 4 gallons per minute. Rebate: \$10 per showerhead. Limit 4 per household; replacements only.
