

**RESOLUTION  
OF THE BOARD OF DIRECTORS OF  
CASTLE PINES NORTH METROPOLITAN DISTRICT**

**2024 BUDGET AMENDMENT**

WHEREAS, the Board of Directors of Castle Pines North Metropolitan District adopted the budget and appropriated funds for the 2024 fiscal year as follows:

2024 General Fund	\$0
2024 Conservation Trust Fund	\$50,200

WHEREAS, the District’s consultants have determined that certain non-business-type Revenues and Expenditures are more appropriately assigned to the General Fund, including property taxes, other tax revenue, lease revenues and related fund transfers as well as an appropriation of a TABOR Reserve;

WHEREAS, the District also requires an increase to its Conservation Trust Fund (CTF) to account for higher than anticipated receipts related to State of Colorado CTF proceeds and expenses related to an Inter-governmental Agreement with the City of Castle Pines; and

WHEREAS, the expenditure of such funds is a contingency which could not have been reasonably foreseen at the time of adoption of the budget.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Castle Pines North Metropolitan District hereby adopts a supplemental budget and appropriation for the 2024 fiscal year as follows:

2024 General Fund	\$2,121,690
2024 Conservation Trust Fund	\$97,945

BE IT FURTHER RESOLVED that such sums are hereby appropriated from the revenues of the District to the proper funds for the purposes stated.


